Foundation House, an extended care, sober-living program incorporating 12-Step, Holistic, Athletic, Art, Music, LADC, and Wilderness Therapy, seeks a full-time Clinical Therapist for its Portland, ME location. The Clinical Therapist will provide counseling, case management and support to a caseload assigned by the Clinical Director and or CEO. This position is integral to the foundation of recovery we offer each Resident, which is based upon the supportive culture and excellent quality of their home and experience therein—hence our name, FOUNDATION HOUSE. We believe that creating, maintaining, and teaching an environment of excellence in the residences has a fundamentally positive impact on resident success in early recovery.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Creates and facilitates an intake plan for new residents including designating a mentor, communicating with referring program therapist and/or educational consultant, and all other activities to better understand each assigned resident's need
- Completes intake and all associated paper work on incoming clients and reports any concerns or anticipated needs to staff
- Provides individual and group counseling to assigned caseload
- Responsible for ongoing communication and outreach to assigned clients' parents/guardians and referring therapist
- Completes documentation of individual/group sessions, parental contact, educational consultant/primary treatment completed each day
- Provides guidance in regards to sober living, school, work, volunteering, sponsor/AA meetings, parental conflict and probation/legal issues
- Holds clients accountable to Foundation House rules and expectations and checks in with clients who receive disciplinary warnings
- Works through transitional planning with clients starting well in advance of intended discharge date and completes a discharge summary after clients leave Foundation House

- Arranges and facilitates meetings with parents when requested
- Attends assigned meetings including regular team meetings, supervision meetings and roster review
- Acts as a team member by covering other therapists when requested
- Must be flexible to provide on call/night/day coverage as assigned by the Clinical Director and/or CEO and after hours support for clients
- Maintain current licensure
- Others duties as assigned by the Clinical Director and/or CEO
